Summary:

Perform daily operations and maintenance of Aqua's water production systems.

Essential Duties and Responsibilities include the following. Other duties may be assigned.

- Solely responsible for the proper functioning and maintenance of the water production treatment facilities and equipment in assigned region, including wells, treatment facilities, and property.
- Perform daily inspection of Aqua's water production systems.
- Perform routine maintenance activities or submit work order to maintenance group for maintenance beyond capabilities. Operator is responsible for ensuring completion of any required maintenance in assigned region.
- Perform routine tests on water treatment facility filters, treatment process, chemicals, pumps, motors, and water, and takes appropriate reading of gauges and meters.
- Monitor water quality, equipment metrics, and system performance, including comparison of actual readings to SCADA system data.
- Maintain water quality, equipment, and production records in accordance with regulatory compliance requirements.
- Ensure cleanliness of water facilities and cleans equipment as necessary.
- Receive, process, and close electronic work orders.
- Use maps to locate Aqua's water production and distribution system equipment and infrastructure.
- Use GPS devices to read and record coordinates of Aqua's system equipment and infrastructure.
- Locate and report water leaks.
- Respond to call-out and on-call duties as necessary.
- Perform other tasks as designated by supervisory personnel.

Qualifications:

To perform this job successfully, an individual must be able to perform each essential duty satisfactorily. The requirements listed below are representative of the knowledge, skill, and/or ability required. Reasonable accommodations may be made to enable individuals with disabilities to perform the essential functions.

Education/Experience:

High school diploma or general education degree (GED); two (2) years' experience as a water operator; or equivalent combination of education and experience.

Language Ability:

Ability to read and comprehend simple written procedures and instruction manuals. Ability to write simple correspondence. Ability to effectively present information in one-on-one and small group situations to customers, clients, and company employees.

Math Ability:

Ability to add, subtract, multiply, and divide in all units of measure, using whole numbers, common fractions, and decimals. Ability to compute rate, ratio, and percent and to draw and interpret bar graphs.

Reasoning Ability:

Ability to apply common sense understanding to carry out detailed but uninvolved written or oral instructions. Ability to deal with problems involving a few concrete variables in standardized situations.

Computer Skills:

Work Order Processing, Word Processing, Excel, E-Mail, Internet Software.

Other Knowledge, Skills, & Abilities:

Ability to operate instruments for acquiring GPS coordinates and associated data.

Certificates and Licenses:

Valid State of Texas Driver's License. Texas Class D Water Operator Certificate and ability to obtain Texas Class C Groundwater Operator Certificate within one (1) year of hire.

Specialized Training:

Appropriate training in handling and disposition of hazardous materials.

Supervisory Responsibilities:

This position has no supervisory responsibilities.

Work Environment:

The work environment characteristics described here are representative of those an employee encounters while performing the essential functions of this job. Reasonable accommodations may be made to enable individuals with disabilities to perform the essential functions.

While performing the duties of this job, the employee is regularly exposed to fumes or airborne particles, and outdoor weather conditions.
